TERMS AGREEMENT

The undersigned ("Purchaser") agrees that all purchases made by Purchaser from C&C Meat Sales, Inc. ("Seller") are subject to the following terms and conditions.

1. All amounts due for goods and services purchased from Seller are payable at the Seller's distribution facility from which the goods and services are delivered. Purchaser acknowledges that such amounts are not payable in installments, but are payable in full as stated herein. All amounts due Seller are payable in accordance with the payment terms granted by Seller's credit department from which the goods and services are delivered.
2. A financial statement should be submitted with this application. Purchaser understands and agrees to meet the Net 7 day terms if credit is made available and should a credit availability be granted by C&C Meat Sales, Inc. All decisions with respect to the extension or continuation shall be in the sole discretion of C&C Meat Sales, Inc. C&C Meat Sales, Inc. may terminate any credit availability within its sole discretion.
3. Purchaser shall pay Seller a service charge in an amount of \$25.00 for all checks returned by Purchaser's bank; provided, however, that such service charge shall not be due and payable in the event such payment would result in the violation of the usury laws of the applicable jurisdiction.
4. In the event the account is turned over to an attorney or other agency for collection, or suit is brought on same, or the same is collected through any judicial proceeding whatsoever, Purchaser shall pay **33 1/3% attorney's fees of the amount due hereunder and court costs** incurred by Seller, together with the interest from date of sale at the maximum rate allowed by law or 18%, whichever is the lessor. Should any payment not be made when due, the undersigned authorize any clerk of the court designated by our Company to appear in any court of competent jurisdiction and confess judgement against them for the amount due. Venue for purposes of litigation in the State of Virginia shall be in Fairfax County, or elsewhere at the option of our Company.
5. Purchaser shall notify Seller by certified mail of any change of ownership of Purchaser. Purchaser warrants to Seller that all financial information furnished for the purpose of obtaining credit is true, correct and complete in all material respects, and Purchaser authorizes Seller to investigate all references furnished pertaining to the credit and financial responsibility of Purchaser.

INDIVIDUAL PERSONAL GUARANTY

I, _____, for and in consideration of your extending credit at my request to _____ (the "Company"), personally guarantee prompt payment of any obligation of the Company to C&C Meat Sales, Inc. ("Seller"), whether now existing or hereinafter incurred, and I further agree to bind myself to pay on demand any sum which is due by the Company to Seller whenever the Company fails to pay same. It is understood that this guaranty shall be an absolute, continuing and irrevocable guaranty for such indebtedness of the Company.

I expressly waive presentment, demand, protest, notice of protest, dishonor, diligence, notice of default or nonpayment, notice of acceptance of this guaranty, notice of the extending of any guaranteed indebtedness already or hereafter contracted for by the Company, notice of any modification or renewal of any credit agreement evidencing the indebtedness hereby guaranteed, notice of any renewal or extension of such indebtedness, and I expressly consent to any modification or renewal of any credit agreement evidencing the indebtedness hereby guaranteed and to all renewals or extensions of such indebtedness. I further waive any right to require Seller to proceed against, or make any effort at collection of the guaranteed indebtedness from, the Company or any other party liable for such indebtedness.

If the guaranteed indebtedness is not paid by me when due, and this guaranty is placed in the hands of an attorney for collection, or suit is brought hereon, or it is enforced through any judicial proceeding whatsoever, I shall pay **33 1/3% attorney's fees of the amount due hereunder and court costs** incurred by Seller, together with interest from date of sale at the maximum rate allowed by law or 18%, whichever is the lessor.

In the event more than one party executes this Guaranty as a guarantor, then each guarantor agrees to be jointly and severally liable for the guaranteed indebtedness, and, in all instances herein, the singular shall be construed to include the plural.
